

OFFICE OF THE DIRECTOR OF NATIONAL INTELLIGENCE INTELLIGENCE COMMUNITY POLICY MEMORANDUM NUMBER 2005-200-1

Subject: Authorities, Roles, and Responsibilities of the Deputy Director of National Intelligence for Analysis

Authority: The National Security Act of 1947, as amended; the Intelligence Reform and Terrorism Prevention Act of 2004; Executive Order 12333, as amended; and other applicable provisions of law.

- 1. The Deputy Director of National Intelligence for Analysis (DDNI/A) is charged with the implementation of the responsibilities of the Director of National Intelligence (DNI) relative to the processing, analysis, and dissemination of national intelligence analytic products.
- 2. The DDNI/A is supported by the following Assistant Deputy Directors and such other Assistant Deputy Directors as may be appointed by the DDNI/A, with the responsibility for the management of their respective subject areas, under the direction of the DDNI/A:

Assistant Deputy Director for the President's Daily Briefing

Assistant Deputy Director for the National Intelligence Council

Assistant Deputy Director for Analytic Integrity and Analytic Ombudsman

Assistant Deputy Director for Technology

Assistant Deputy Director for Analytic Mission Management

Assistant Deputy Director for Community Support

- 3. The DDNI/A is delegated the following authorities and responsibilities of the DNI set forth in the National Security Act of 1947, as amended, and other applicable provisions of law, unless otherwise prohibited by statute, Executive order, or this Memorandum:
 - a. All authorities and responsibilities of the DNI with respect to establishing analytic priorities for the Intelligence Community to ensure timely and effective collection, processing, analysis, and dissemination of national intelligence. These authorities and responsibilities will be exercised in coordination with the Deputy Directors of National Intelligence for Collection and Customer Outcomes (DDNI/C and DDNI/CO);
 - b. Consistent with intelligence priorities, all authorities and responsibilities of the DNI with respect to establishing objectives and guidance for the Intelligence Community to ensure timely and effective analysis of national intelligence, and, in coordination with the DDNI /C, such authorities and responsibilities with respect to the dissemination and

processing of national intelligence analytic products;

- c. All authorities and responsibilities of the DNI to manage and direct the tasking of analysis, production, and dissemination of national intelligence analytic products, including the responsibility to identify analytic knowledge gaps and evaluate the analytic posture across the Intelligence Community;
- d. All authorities and responsibilities of the DNI with respect to providing advisory tasking regarding analysis, and the production and dissemination of national intelligence analytic products by elements of agencies and departments not within the National Intelligence Program;
- e. All authorities and responsibilities of the DNI to ensure the most accurate analysis of intelligence is derived from all sources to support national security needs, by
 - (i.) Implementing policies and procedures to:
 - (a) encourage sound analytic methods and tradecraft throughout the elements of the Intelligence Community;
 - (b) ensure that analysis is based upon all sources available; and
 - (c) ensure that the elements of the Intelligence Community regularly conduct competitive analysis of analytic products, whether such products are produced by or disseminated to such elements;
 - (ii.) In coordination with the DDNI/CO, ensuring that analytical production addresses customer needs;
 - (iii.) In concert with the DDNI for Management (DDNI/M) and the DDNI/C, helping ensure that resource allocation for intelligence analysis is appropriately proportional to resource allocation for intelligence collection systems and operations in order to maximize analysis of all collected data;
 - (iv.) Ensuring that differences in analytic judgment are fully considered and brought to the attention of policymakers; and
 - (v.) In concert with the DDNI/C, ensuring that sufficient relationships are established between intelligence collectors and analysts to facilitate greater understanding of the needs of analysts and to ensure a systematic effort is made to base collection of intelligence on the needs and intelligence gaps that are identified by the policy and analytic communities.
- f. All authorities and responsibilities of the DNI with respect to the National Intelligence Council;
- g. All authorities and responsibilities of the DNI under section 1017(a) of the Intelligence Reform and Terrorism Prevention Act of 2004, with respect to alternative analysis of intelligence by the Intelligence Community;
- h. All authorities and responsibilities of the DNI under section 1019 of the Intelligence Reform and Terrorism Prevention Act of 2004, with respect to analytic integrity;

- All authorities and responsibilities of the DNI under section 1020(a) of the Intelligence Reform and Terrorism Prevention Act of 2004, to safeguard objectivity in intelligence analysis;
- j. The authority and responsibility for the tradecraft, production, and dissemination of the President's Daily Briefing and the management of the President's Daily Briefing staff;
- k. In coordination with the DDNI/C, the authorities and responsibilities of the DNI with respect to ensuring that the Intelligence Community makes efficient and effective use of open-source information;
- The authority and responsibility for providing national intelligence support to the Principals and Deputies Committees;
- m. The responsibility to support the Deputy Director of National Intelligence for Management (DDNI/M), in establishing competency, qualification, training, career development, and performance standards and requirements to meet the present and future analytic requirements of the Intelligence Community; and
- n. In coordination with the DDNI/M, the responsibility and authority to coordinate the performance of services of common concern to the Intelligence Community with respect to the responsibilities and authorities enumerated in subparagraphs a. – m. above.
- 4. To the extent authorized by law, the DDNI/A may further delegate to any other officer or official of the ODNI the authorities identified in paragraph 3 above.
- 5. This Policy Memorandum is effective immediately, and the relevant contents shall be incorporated into an Intelligence Community Directive.
