Subj: DISESTABLISH U.S. NAVY INFORMATION OPERATIONS COMMAND,

MENWITH HILL, UK AND REALIGN U.S. NAVY INFORMATION

OPERATIONS DETACHMENT, DIGBY, UK

(b) OPNAVINST 5400.45

- 1. <u>Purpose</u>. To implement Secretary of the Navy approval of the disestablishment of U.S. Navy Information Operations Command (NAVIOCOM), Menwith Hill, UK and to approve the realignment of the U.S. Navy Information Operations Detachment (NAVIODET), Digby, UK, per reference (a).
- 2. <u>Background</u>. This disestablishment action results from the National Security Agency's Defense Department Directive of October 2012 which directed removal of all manpower resources from NAVIOCOM Menwith Hill. That action will be completed by September 2015 and the activity will be closed. The mission of subordinate NAVIODET Digby will continue and the NIODET will be realigned under NAVIOCOM Maryland.
- 3. <u>Organizational Changes</u>. Effective 30 September 2015, disestablish NIOCOM Menwith Hill, UK and realign NIODET Digby, UK. The following applies:

# 4. Action

- a. Commander, U.S. Fleet Cyber Command (COMUSFLTCYBERCOM) and Commander, U.S. Fleet Forces Command (COMUSFLTFORCOM) will take appropriate action to disestablish and realign subject activities.
- b. Master Update Authority, Honolulu, HI will delete the PLA in the Central Directory Component via messaging systems effective immediately upon COMUSFLTCYBERCOM or COMUSFLTFORCOM request to Commander, Naval Network Warfare Command (COMNAVNETWARCOM) (Network Operations 321), 112 Lake View Pkwy, Suffolk, VA 23435-2696, via email at C20IX Reg@navy.mil or by calling (757) 203-0338/0339. PLA will be deactivated via messaging systems. - 5. <u>Records Management</u>. Records created as a result of this notice, regardless of media or format, shall be managed per Secretary of the Navy Manual 5210.1 of January 2012.
