Dear Sir/Madam:

This is a request under the Freedom of Information Act.

We request a copy of photographic and video images of abuses committed against Iraqi prisoners held in the custody of U.S. government or Coalition forces in Iraq.

In testimony before the Senate Armed Services Committee last week, Secretary Rumsfeld indicated that the Department was in possession of at least three compact disks containing such images.

We request a copy of the contents of those disks.

This material has reportedly been classified as national security information. If so, I believe that would be a violation of Executive Order 12958, as amended, which states (Sec. 1.7) that "In no case shall information be classified in order to: (1) conceal violations of law...."

We would not object if the images were modified prior to release so as to protect the privacy of the individual victims.

We further request a fee waiver of search and copying costs, on the following grounds:
