This letter formally responds to your email request dated January 6, 2015, for declassification of certain information classified under the Atomic Energy Act. You requested "... that the Department of Energy [DOE] (and the Department of Defense [DoD]) authorize declassification of the size of the total U.S. nuclear stockpile and the number of weapons dismantled as of the end of fiscal year 2014." Your request was forwarded to DoD for consideration by the Formerly Restricted Data Declassification Working Group (FRD DWG) on January 9, 2015.

The information requested was declassified jointly by the DoD and DOE on April 10, 2015. Please find enclosed a copy of the 2014 totals as part of larger tables.
